May '99 Colorado Workshop Plans for Tomorrow

DENVER, COLORADO — DERA and the Western Insurance Information Service (WIIS) will co-host the third annual "Planning for a Safer Tomorrow" workshop in Denver on May 18, 1999, in conjunction with the National Flood Insurance Program conference.

The program will focus on flood preparedness, mitigation, response and recovery. FEMA Director James Lee Witt will open the workshop by presenting a national policy perspective. Keynote speaker will be the Governor of Colorado. Bill Owens.

DERA members and others interested in flood preparedness and response issues are invited to attend the workshop.

The workshop will feature a panel discussion and exercise demonstration highlighting flood mitigation and emergency response considerations. Panel members include meteorologist Mike Nelson (KUSA-TV); Oestman, flood insurance specialist; Marsha Hilmes, Ft. Collins Floodplain Administrator; Diane Venard, American Red Cross; and Don Bobeda, real estate agent. Previously flooded homeowners and state emergency management planners will participate.

While the focus of discussions will be Colorado's experience with floodplain management, flood mitigation and response efforts, individuals from outside the state will still find the presentations relevant. Within the U.S., flood preparedness and insurance guidelines are generally uniform, although there are significant differences in local

will give all attendees the opportunity to compare their experiences with model programs from throughout the U.S. and abroad.

In addition, an exhibit hall with over 60 governmental information and product demonstration exhibits will be open during the afternoon.

The Colorado Office of Emergency Management, the Colorado Natural Hazards Mitigation Council, the American Red Cross and DERA will provide exhibits where attendees an obtain an extensive amount of literature on flood preparedness, mitigation measures, and emergency response procedures.

Bob Kistner represented DERA throughout the year-long preparation for this workshop, while Jerry Cassidy helped with administration and logistics. Carole Walker and Shannon Kelly from WIIS worked diligently to develop an exciting program, arrange distinguished speakers, and coordinate sponsors.

DERA members should plan to arrive for an 8:00 a.m. membership breakfast and roundtable. The registration desk opens at 7 a.m., and the workshop begins at 9 a.m.

I'm looking for volunteers to take on the following DERA projects. If you are interested, please drop me a note or email as soon as possible:

Director, NIAR/India Joint Project. This will be a multi-year project which initially involves recruiting amateur radio operators and other technical specialists to go to India for 2-3 week periods for teaching. Travel to and from India is at the individual's expense, but in-country lodging, local transportation, and some meals will be provided by NIAR. Within two years, the project will expand to include emergency planners, firefighters, search and rescue specialists, and flood mitigation specialists. The Director is responsible for coordinating with NIAR (our partnership organization in India) recruiting and scheduling volunteers, and transitioning the program to a larger scale over the next two years, as well as working with the World Bank and other funding sources to provide long-range financing of the project. Expected work hours are 5-10 hours per week in 1999, growing to 20 hours per week within two years.

Initially, this will be an unpaid position, but one of our goals is to obtain grant support by the end of 1999, under which a part time director would be funded. In addition, we would aim to find grant support to partially reimburse the volunteers' air travel to India. The director should be prepared to assist in locating financial support and to develop an extensive public information program for the project.

Membership Services Manager. We need a volunteer--preferably one within an hour or two of Denver, Colorado--to manage membership services. The manager would be responsible for processing membership applications, maintaining the membership directory, writing a column for the newsletter, and answering inquiries from prospective members.

On average, the job takes about 5-7 hours per week. Our membership management program runs on a 486 or better PC, and the manager would need access to a laser printer. There is no salary for the job, but expenses are reimbursed.

While we'd like a volunteer somewhere near Denver to facilitate coordination with the home office, we would consider applicants who have a workable strategy for "virtual officing" this job.

Please let me hear from you if you're interested in either of the above jobs.

In closing, I'd like to again say thanks to you for your continued support and membership. Please help our organization grow stronger by recruiting a new member this month. There's always an application form on the back page of each newsletter.

Report from Sudan

Editor's Note: Mr. John Lobor is a DERA member who serves as Branch Director for the Sudanese Red Crescent Society in the state of Bahr el Jebel in Sudan. The Republic of Sudan is the largest country in Africa and has a population of about 34 million people, 32% of whom live in urban areas. The official language is Arabic, but Nubian and Ta Bedawie are also spoken. Over 70% of the population is Sunni Muslim while 25% practice indigenous beliefs. The economy relies mainly on textile processing, agriculture, petroleum, and mining. Over 80% of the population make their living from agriculture, 10% from industry and commerce, and about 6% from government employment. The Gross Domestic product is \$860 per capita. Sudan borders the Sahara desert and overall only 5% of the land is arable. There are deserts in the north on either side of the Nile. rich farmlands and forests in center of the country, and fertile but very wet regions in the south. Mr. Lobor sent us the following report:

The Sudanese Red Crescent Society (SCRS) is a member of the International Red Cross movement. Our society was established in 1956 and now has 21 state offices, out of the 26 states in the country. The SRCS has a membership of many thousands of volunteers and about 250 paid staff, all of whom are Sudanese nationals.

I live in Juba, a town in south Sudan, and am currently heading a branch office in Bahr el Jebel state.

I joined the SRCS in 1988 as a volunteer while still a student at the University. After graduating in 1990, I was appointed as an administrator to assist the branch director in establishing the branch office in Juba. In 1994, I was confirmed as the branch director. We now have more than 350 active volunteers in my office.

In addition to being responsible for branch administration and service activities, I conduct training programs for volunteers and community members in disaster preparedness, concentrating on the following topics: Disaster preparedness, needs assessment, planning and emergency response, logistics management, camp management, health and nutrition in disaster situations, monitoring/reporting/evaluation.

Last year I participated in a training program for 38 community development officers at Amadi Rural Development Institute where I presented lectures in disaster preparedness.

This year, our branch office plans to train 45 new volunteers. Chief activities of the SCRC include relief assistance for refugees and internally displaced persons (IDPS), vulnerable individuals including the elderly, blind, leprosy affected, and flood victims; health programs; tree planting; water harvesting; exchange of Red Cross messages for separated family members; and promotion of the fundamental principles of the Red Cross and Red Crescent movement.

The main αganizations working with us in partnership are the International Committee of the Red Cross (ICRC) and the International Federation of the Red Cross and Red Crescent Societies (IFRC), as well as other cooperating organizations.

A major problem hindering our training programs is lack of training materials and

reference books. I would greatly appreciate any teaching materials, books, texts, or pamphlets which other DERA members could send to me. I especially need help getting the following materials:


