# **Steven D. Keene**

**Chair, DERA Board of Trustees**



Steve Keene, Chairman of our Board of Trustees, died unexpectedly on November 24, 2007. Steve lived in Fox Point, Wisconsin with his wife, Deborah, and their two sons, Andrew and Benjamin.

Steve had been an active member of DERA since 1990, and became a Trustee in 1998. He was instrumental in DERA's reorganization in 1991-92, and our nonprofit incorporation in Wisconsin in 1993.

Steve organized and led DERA's first "Planning for a Safer Tomorrow" community workshop in Milwaukee in the spring of 1995 and spearheaded a similar workshop in Chicago later that year, followed by annual events in Asheville, North Carolina (1996 and 1997), and Colorado (1998 and 1999).

For many years, Steve was the face of DERA at the International Disaster Management Conference, where he ran our information booth and chaired our membership meetings.

In recent years, Steve's job limited his ability to travel for DERA, but he redoubled his efforts working behind the scenes for DERA on long range planning, volunteer development and our awards program.

Steve left a highly successful career in telecommunications to take a key civil service position with the U.S. Department of Justice, where he specialized in community safety and security. His recent projects included school safety planning and a community education and outreach program aimed at making streets safer for children.

In 1997, Steve and his family established the DERA Heroic Service Award program in memory of his brother Sam, who along with two others perished in an aircraft landing accident in April 1997 at the Tegucigalpa, Honduras airport. Sam was loadmaster aboard a U.S. Air Force C-130 delivering food, medical kits and communications equipment. Steve personally presented the Heroic Service Award to DERA members who had gone beyond the call of duty that others might live.

Everyone on the DERA leadership team joins in sending Debbie, Andrew and Benjamin our heartfelt sympathy. We also extend our sincerest condolences to Steve's parents, Harold and Phyllis Keene, and to his brothers and sisters, Lonnie Keene, Allen Keene, Gail Brinton, Karen DeLorenzo, and Melanie Orlofsky.

A scholarship fund for Andrew and Benjamin has been established by Steve's friends and colleagues in Milwaukee.
